Overview

Aluminum Post and Screws, also known as Binding Screw Posts or Chicago Screw Posts are great for assembling sample books, catalogs, price lists, hobbies and crafts, and any other application that needs fastening. Post and screws are extremely simple to use; the screw is easily affixed to the threaded post, providing simple and secure binding. Gane's post and screws are constructed of aluminum and available in a wide range of sizes.

- Base Material: Aluminum
- Available in 100, 250, 500, and 1,000 packs
- Stocked sizes: 1/4", 3/8", 1/2", 5/8", 3/4", 7/8", 1", 1-1/4", 1-1/2", 1-3/4", 2", 2-1/4", 2-1/2", 2-3/4", 3", 3-1/2", and 4"
- 1/4" long binding posts use 1/4" screws, all other binding posts use 3/8" long screws.
- Thread class is 8/32; shaft diameter is 13/64" and top diameter is 3/8".
- Length of usable internal thread:
 - Binding Posts: Posts 3/8" long and under are drilled and tapped full length. Posts over 3/8" long have 3/8" usable thread.
 - Extensions: All lengths of extensions, other than 1/4", have 3/8" of usable thread.
- Also available: non-standard sizes, post only, anodized, colored, and plastic. Request information on these.
